

Fur the Love of Dogs Bed & Breakfast Contract

Please read carefully. This agreement includes a release of liability and waiver of legal rights and deprives you of the right to sue FTLOD Inc., and related parties. Do not sign this agreement unless you have read it in its entirety and understand its effect, policies, procedures, pet release, waiver of liability, assumption or risk, and indemnification agreements.

In consideration for my pet(s) name _____ being permitted to be a pet guest at FTLOD, by signing this document, I _____, Owner/Guardian, make the following representations, certify the accuracy of all information provided to Fur the Love of Dogs at any time, and agree to all the following policies, procedures, terms and conditions stated below in this FTLOD Inc. overnight stay and services agreement.

- 1) Owner/Guardian, I represent that I am the owner and/or authorized guardian of my pet and I am fully authorized to enter this agreement.
- 2) I understand that Fur the Love of Dogs Inc. reserves the right to deny admittance to any pet for any reason, at any time.
- 3) I represent that my pet meets all of the following requirements: (1) is four months of age or older, (2) is current on his/her required vaccinations, (3) is on a monthly flea and tick preventative medication, (4) has been in good health for the last 30 days prior to check-in, (5) my pet is not aggressive, (6) I have completed the Dog Profile, (7) my dog will enter and exit Fur the Love of Dogs Inc. facility on a leash.
- 4) I understand that pets cannot be admitted or released when lobby is closed. **NO EXCEPTIONS**
- 5) The lobby is closed for check-in or Check-out on New Year's Day, Memorial Day, Easter, Independence Day, Labor Day, Thanksgiving Day and Christmas Day
- 6) Owner agrees to pay the rate for overnight stay in effect on the date the pet is checked into the Bed & Breakfast Suite.
- 7) Owner agrees to pay all costs for special services requested for the pet during the time it is in the care of the Bed & Breakfast Suite.
- 8) The owner specifically represents to FTLOD that the pet has not been exposed to rabies, parvo, or distemper within 30 days prior to current services, and further, said pet has received an annual rabies, distemper, and bordetella vaccination which can be confirmed by the veterinarian. If said vaccines cannot be confirmed, FTLOD has the authority to refuse admittance of the pet.
- 9) I am aware and understand that FTLOD employees are not veterinarians and do not have backgrounds in animal medicine. FTLOD employees are not expected to diagnose or detect illnesses in the pets that are staying in our Bed & Breakfast or cage free areas. I agree to assume all risk associated with administration of medication/supplements by FTLOD employees during my pet's stay. I HEARBY AGREE TO INDEMNIFY FUR THE LOVE OF DOGS INC, ITS OWNERS, DIRECTORS, OFFICERS, EMPLOYEES AND AGENTS AGAINST ANY CLAIMS MADE AGAINST FUR THE LOVE OF DOGS INC. ITS OWNERS, DIRECTORS, OFFICERS, EMPLOYEE, AND AGENTS AS A RESULT OF MY FAILURE TO INFORM FTLOD INC. OF ANY PRE-EXISTING MEDICAL CONDITIONS THAT MY PET MAY HAVE AND CAN BE TRACED THROUGH VETERINARIAN CARE IN THE PAST.
- 10) Veterinarian Care, I agree to allow FTLOD to obtain veterinarian medical treatment for my pet, if, in its sole discretion it appears that, the pet is ill, injured, or exhibits any other behavior that would reasonably suggest that my pet might need medical treatment. Medical treatment may require transportation of my pet to receive care and I hereby authorize such transportation. I grant Fur the Love of Dogs Inc. full authority to make decisions involving the medical treatment of my pet during its stay at Fur the Love of Dogs Inc. I agree that I am fully responsible for the cost of any such medical treatment and transportation.
- 11) In addition, I agree that if my pet is injured by another pet, I hereby release Fur the Love of Dogs Inc., its owners, employees and agents from all liability and financial responsibility for such injury. I further understand that if my pet bites a human or pet, that Fur the Love of Dogs Inc. may contact the appropriate authorities.

- 12) *Dog Daycare*, I understand that FTLOD is a cage-fee facility utilizing playgroups where multiple dogs interact. I understand that dogs play with their mouth and paws, which can result in nicks and scratches on my pet. While Fur the Love of Dogs Inc. provides reasonable care and supervision in the playgroups, I understand and agree that FTLOD Inc. employees may not notice these nicks or scratches before my pet's departure and therefore, I might not be notified.
- 13) *Reservations*, I understand that confirmed reservations are made when a monetary deposit is put down at least three (3) days prior to drop off date during non-peak times. During peak holiday's (see website for details) there is a five (5) day reservation requirement to hold your reservation.
- 14) *Cancellations*, I understand that all confirmed reservations for NON-HOLIDAY/NON-PEAK DAYS must be cancelled at least three (3) days prior to my pet's reserved arrival date. I further understand that a cancellation made within less than three (3) days of my pet's arrival date or a no-show will result in a \$50.00 charge. Deposits will be offered as credit only. **HOLIDAY/PEAK DAY POLICY:** I understand that all confirmed reservations for HOLIDAY/PEAK DAYS must be cancelled at least seven (7) days prior to my pet's reserved arrival date. I further understand that cancellation due to any circumstance made within less than seven (7) days of my pet's reserved arrival date, or a no show, will result in a \$75 charge deposits will be offered as credit only.
- 15) *Rescheduling*, If an overnight visit is rescheduled, the deposit will be transferable to next arrival date, when rescheduled within the cancellation policy terms.
- 16) *Check in & Check out times*, I understand that checking in before 7am incurs an additional fee of \$5.00 for every 15 mins. Check out time is 11:00 am. I understand checking my pet out after 11:00 am will incur a charge of \$25.00.
- 17) *Early departure*, Regardless of reason, once a pet's stay has begun, I understand that I am responsible for payment of all days reserved, regardless of picking my pet up prior to the scheduled departure date. Once you reserved your room we cannot book this room again for other interested parties and cater to your pet(s) needs only during this time.
- 18) I acknowledge that I have received, reviewed and signed a copy of the FTLOD contract agreement. I hereby agree to be fully bound by all the terms and conditions of Fur the Love of dogs Inc. contract.
- 19) *Duty to Disclose*, I represent that I have disclosed and shall continue to disclose, any and all medical conditions or any other conditions, including, but not limited to, personality concerns or behaviors that may affect, limit, or prevent my pet's ability to participate in services provided by Fur the Love of Dogs Inc. I understand that FTLOD Inc. is relying on and will rely on those representations to provide a safe and pleasant environment for both humans and animals.
- 20) This writing represents the sole agreement between Fur the Love of Dogs Inc. and the Owner/Guardian.
- 21) Each time I bring my pet into Fur the Love of Dogs Inc., I am re-affirming the terms of this agreement, including updated claims, and the truthfulness and accuracy of all the statements I have made in the agreement.

I understand that Fur the Love of Dogs Inc. will exercise all due diligence and care in the guardianship of my pet. I, the undersigned, hereby acknowledge and agree that all the information in this application is complete and accurate to the best of my knowledge. I further attest that if I am not the sole owner or representative of the dog subject to this application that my signature is sufficient to enter into this contract for and on behalf of any other owner or representative. I hereby waive and release Fur the love of Dogs Inc., it's employees, owners, and agents from any and all liability of any nature, for injury or damage, including that which may result from the action of any dog including my own, and I expressly assume the risk of such damage or injury while my dog participates in or attends any function or services of Fur the Love of Dogs Inc. while on the grounds or the surrounding area thereto.
